

FUND STRATEGY

The Tocqueville Gold Fund seeks to achieve its investment objective by investing at least 80% of its net assets, plus borrowings for investment purposes, in gold and other precious metals and securities of companies located throughout the world that are engaged in mining or processing gold. The Fund follows a value approach to investing and the portfolio manager will identify companies that are undervalued based on his judgment of relative value and growth potential.

QUARTERLY UPDATE

- Gold finished 2018 at \$1281 an ounce, rising 7.1% during the fourth quarter of 2018. Trade rhetoric and initially a strong U.S. dollar drove gold early in the quarter. However, the market's expectation of lower interest rates versus the U.S. Federal Reserve's comments that rate hikes would continue into 2019 jolted capital markets into volatile swings. Greater volatility in the broader markets found investors seeking gold as the dollar rolled over with higher interest rates and the U.S. Government shutdown.
- During 4Q 2018, the Fund rose 3.29% while the Philadelphia Gold and Silver Index rose 8.69%. Top contributors to performance included B2Gold Corp., Franco-Nevada Corp., and AngloGold Ashanti. Top detractors included Corvus Gold, Gold Standard Ventures, and SEMAFO.
- While a debt crisis forecast has been made for many years by gold advocates without materializing, in our view, it now appears imminent, with the debt to GDP ratio in excess of 100%. We believe that the U.S. debt is now more likely to outgrow the U.S. economy's ability to credibly service it. The development of this relationship has historically defined the transition into a currency collapse. U.S. debt is growing at 5%, assuming no recession over the next 5 years. It would be difficult to sustain that pace in real terms with 70% of government spending on automatic pilot due to major, untouchable entitlement programs. The interest on that debt would crowd out productive capital and potential growth, while encouraging calls to support greater government entitlements. Other means to cover rising debt levels, such as tax increases, will not erase the deficit and more likely would slow economic growth.
- We feel gold exposure is the antidote to repercussions stemming from a sovereign debt crisis. In our view, gold has always protected capital from currency debasement. The tide of easy credit and risk taking appears to be receding. If so, exposure to gold would be timely and potentially rewarding.




GLOSSARY OF TERMS

P/E: The weighted average of the price/earnings (P/E) ratios of the equity securities referenced. The P/E ratio is calculated by dividing the current price of the stock by the trailing earnings per share for the past 12 months.

The Philadelphia Stock Exchange Gold/Silver Index is a good indicator of the performance of the common stock of companies in the gold and silver mining industry. It does not incur fees and expenses. **The S&P 500 Index** is a market-value weighted index consisting of 500 stocks chosen for market size, liquidity, and industry group representation. You cannot invest directly in an index.

The Morningstar Equity Precious Metals Portfolio focuses on mining stocks, though some do own small amounts of gold bullion. Most portfolios concentrate on gold-mining stocks, but some have significant exposure to silver-, platinum-, and base-metal-mining stocks as well. Precious-metals companies are typically based in North America, Australia, or South Africa.

The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The Morningstar Rating does not include any adjustment for sales loads. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns.
