

FUND STRATEGY

The Fund seeks to achieve its investment objective by investing in the common stocks of small and mid-cap companies which have the potential to deliver above-average long-term earnings growth, in which earnings and sales growth, valuation, and profitability are assessed through fundamental-based research. The Fund looks for companies which are market leaders in growth industries, have a strong brand name, and whose sales and earnings have increased at a consistent rate. The investment approach includes the analysis of company financial statements in addition to meeting with corporate managements.

QUARTERLY UPDATE

- In the 1st quarter of 2021, the Fund returned -6.28% after fees compared to the Russell 2500 Growth Total Return Index which returned 2.49%.
- During the quarter, the 10-year Treasury Bond nearly doubled starting the year at .92% and finished the quarter at 1.74%. The accommodative monetary policy the Federal Reserve is enacting combined with fiscal stimulus and the economy reopening from COVID-19 stoked inflation fears. As a result, the technology sector underperformed other cyclically sensitive sectors like industrials and consumer discretionary. Despite these macro-economic dynamics, the Fund's holdings in the technology sector continue to execute extremely well as businesses are spending increasing amounts on digital transformations in areas such as E-Commerce, Software as a Service, and Online payments. We remain confident these areas will see continued growth and the businesses that service these areas will grow revenues and earnings for the foreseeable future.
- Communication services and Materials provided the leading relative performance during the quarter, while Technology and Industrials trailed the benchmark. The Fund held no positions in energy or utilities which detracted 16bps in relative performance versus the benchmark.
- Danimer Scientific, Restoration Hardware, Pinterest, Fortinet Inc, and Workday were the leading contributors on an absolute and relative basis. Detractors from performance included Coupa Software, ServiceNow Inc, Paycom Software, Okta Inc, and Iovance Biotherapeutics.



GLOSSARY OF TERMS

P/E: The weighted average of the price/earnings (P/E) ratios of the equity securities referenced. The P/E ratio is calculated by dividing the current price of the stock by the trailing earnings per share for the past 12 months.

The Russell 2500 Growth Index measures the performance of the small to mid-cap growth segment of the U.S. equity universe. It includes those Russell 2500 companies with higher price-to-book ratios and higher forecasted growth values. You cannot invest directly in an index.

The Morningstar Mid Cap Growth Portfolios feature firms that are projected to grow faster than other mid-cap stocks. The U.S. mid cap range for market capitalization typically falls between \$1 billion and \$8 billion and represents 20% of the total capitalization of the U.S. equity market. Growth is defined based on fast growth (high growth rates for earnings, sales, book value, and cash flow) and high valuations (high price ratios and low dividend yields).
