

FUND STRATEGY

The Fund uses a bottom-up selection process based on fundamental security analysis, and does not try to replicate a benchmark. The approach is contrarian and value oriented. The Fund seeks to find securities that are depressed in price, out of favor with investors, and trading at a substantial discount to intrinsic value. The portfolio manager emphasizes free cash flow generation, balance sheet quality, and the fundamental strength of a business franchise as attributes to identify the most attractive risk/reward propositions across all market capitalizations. The Fund focuses primarily on the securities of U.S. issuers, but frequently invests in non-U.S. issuers. The portfolio will typically contain 60-80 positions.

QUARTERLY UPDATE

- Equity markets fell in the first quarter amid inflation risks, rising short term interest rates, and the Russian invasion of Ukraine. However, nearly full employment, high consumer net worth, fading concerns around COVID and improving supply chains all give reasons for optimism. The flattening yield curve has led some to worry about a recession, a fear we do not share.
- The Fund lost -1.19% after fees during the period, outperforming the S&P 500 which lost -4.60% and trailing the Russell 1000 Value and Russell 3000 Value which lost -0.74% and -0.85%, respectively. The sectors making the biggest contribution were materials, energy and financials while the weakest were information technology, healthcare and communications services.
- The top individual names were Chevron, Nutrien, Deere, Halliburton and Diamondback Energy while the laggards were Applied Materials, Qualcomm, Pfizer, NextEra and Abbott Laboratories.
- The Fund added Activision Blizzard, the video game company, whose shares had been hurt by allegations of a toxic work culture. In January, Microsoft announced plans to acquire the company. We believe regulators are unlikely to block the merger, and if they do, we expect the company will repair its reputation and its gaming franchises should prove durable.
- Another purchase was Halliburton, a leading provider of field services and products to the oil and gas industry. Under-investment by oil and gas producers, along with sanctions against Russia, have left the industry unable to meet demand. Therefore, we expect the next capital investment cycle should benefit Halliburton.
- A variety of positions were reduced or eliminated as they approached valuation targets or due to changes in circumstances, including Apple, Applied Materials, Berkshire Hathaway, Delta, Intel, Nvidia and Pfizer.
- Containing inflation is no easy task, and the Fed faces significant risks in acting too aggressively. As ever, we continue to seek value wherever we may find it.



GLOSSARY OF TERMS

P/E: The weighted average of the price/earnings (P/E) ratios of the equity securities referenced. The P/E ratio is calculated by dividing the current price of the stock by the trailing earnings per share for the past 12 months.

The S&P 500 Index is a market-value weighted index consisting of 500 stocks chosen for market size, liquidity, and industry group representation. You cannot invest directly in an index.

The Morningstar Large-Blend Portfolios are fairly representative of the overall U.S. stock market in size, growth rates, and price. Stocks in the top 70% of the capitalization of the U.S. equity market are defined as large-cap. The blend style is assigned to portfolios where neither growth nor value characteristics predominate.
